Joey Gaskell

Joey was diagnosed with pre b-cell acute lymphoblastic leukemia in October 2018 at just 18 months old. His initial treatment was supposed to be about 2 ½ years but about two weeks before the end of his treatment, we found out that he relapsed in his central nervous system. He is currently in his first month of relapse treatment and the goal is to get him back into remission within that first month. We will know if it worked the week of March 29th. As long as he achieves remission at that point, he will move onto a treatment plan of chemo and radiation for about 1 ½ years.
